All interested agencies, groups, and persons disagreeing with this decision are invited to submit written comments for consideration by the (City) (County) to the (office of the undersigned) (other specified place). Such written comments will be received at (the address specified) on or before *(date). All such comments so received will be considered and the (City) (County) will not request the release of Federal funds or take any administrative action on the project prior to the date specified in the preceding sentence.

(Name of applicant) will undertake the project described above with Neighbor Stabilization Program (NSP) funds from the DCS or the North Dakota Housing Finance Agency under Title III of the Housing and Economic Recovery Act on 2008, Public Law 110-289.

(Name of Applicant) is certifying to the DCS that (Name of Applicant/and Chief Executive Officer or other Certifying Officer of Applicant approved by the DCS), in her/his official capacity as (Office) consent to accept the jurisdiction of the Federal courts if an action is brought to enforce responsibilities in relation to environmental reviews, decision-making and action; and that these responsibilities have been satisfied. The legal effect of the certification is that upon its approval (Name of Applicant) may use the NSP funds and the State and HUD will have satisfied their responsibilities under the National Environmental Policy Act of 1969. The DCS will accept an objection to its approval only if it is on one of the following bases: (a) That the certification was not in fact executed by the certifying officer or other officer of applicant approved by the DCS; (b) That applicant's environmental review record for the project indicates omission of a required decision, finding or step applicable to the project in the environmental review process; (c) The applicant has committed funds or incurred costs before release of funds and approval of the environmental certification by the State; or (d) That another Federal agency has submitted a written finding that the project is unsatisfactory from the view point of environmental quality. Objections to the release of funds on bases other than those stated above will not be considered by the DCS. No objection received after *****(date of last day in state's the 15-day period) will be considered by the State.
